THE LAW

The most recent law that affects Title I is the Improving America's Schools Act (Public Law 102-382 (H.R. 6)). The law requires:

"that school districts have a written policy regarding parental involvement; that parents be involved in the design, operation, and evaluation of Title I; that parents be consulted about home-school activities and be trained to help instruct their children that whenever possible, activities should be presented in the language spoken by the majority of the Title I parents.

The school should have a copy of law on file for you to consult.


